Grundfos REACH SVHC Disclosure (as per January 23rd January 2024 update).

The Registration, Evaluation, Authorization and Restriction of Chemicals Regulation EC 1907/2006, hereinafter referred as REACH, is a European regulation on safe use of chemicals. Under the REACH Candidate List (www.echa.europa.eu/web/guest/candidate-list-table), the European Chemicals Agency identifies substances of very high concern (SVHC) that manufacturers must disclose to customers if used in articles in their products above 0.1% by weight.

Grundfos is actively working with its suppliers to collect this data and has established <u>processes</u> to identify whether SVHCs are contained in its products.

Currently, Grundfos is aware of the presence of below listed SVHCs in its product portfolio.
